Vision Kongelunden is an ambitious urban development project located in the middle of Aarhus. Kongelunden houses multiple major sports facilities and attractions and is uniquely situated in the scenic area connecting Aarhus Bay and the Marselisborg Woods.

As part of the development of the large recreational area a beautiful and groundbreaking football stadium will be built in Aarhus at the present location near Aarhus Idrætspark to the benefit and pleasure of the many. By "beautiful and groundbreakting" is meant:

- that a new football stadium is part of a unit with a focus on quality, coherence and understanding of the area's cultural history as well as the landscape and urban location
- that a new stadium has high architectural quality of professional international standing
- that creates a new and very intense stadium experience in connection with football
- that the stadium must be a modern and intimate football stadium that complies with UEFA's category 4 requirements for international football, and at the same time can accommodate well-functioning facilities for many users and spectators including being able to host concerts at a high international level, without compromising on its primary function as a football stadium.

By "for the benefit and joy of the many" is meant:

- high quality in all users' experiences at the stadium
- high accessibility and openness to the stadium and surrounding area
- possibility of using the stadium and surrounding area in everyday life.

the existing and surrounding stadium buildings worthy of preservation.

The stadium seating capacity for football matches is expected to be between 20,000 and 25,000 spectators. The new stadium in Aarhus is currently expected to be opened on 1 July 2026.

With the object of finding a full-service consultant to plan all the architectural and engineering tasks in connection with the new stadium, the Municipality of Aarhus is launching a design contest. The primary task in the design contest is to deliver a visionary proposal for a new football stadium and to show how the stadium interacts with its surroundings and the neighbouring facilities in the surrounding area and to show how the vision of a beautiful and groundbreaking stadium for the benefit and pleasure of the many may be accomplished. The focus of the design contest is the composition of the football stadium with a connection to the location and

In continuation of the design contest, it is expected that a negotiated tender procedure without publication will be conducted with the winner or winners of the design contest with the object of entering into a full-service consultancy agreement.

The full-service consultant must in general plan the stadium on the basis of a stadium concept prepared by the stadium advisers connected to the employer's adviser (Rambøll and Transform): Trivandi, Sport Five and Core Five in cooperation with the Municipality of Aarhus and the football club AGF.

Concurrently with the invitation to tender in the design contest "New Stadium in Aarhus", tenders will be invited for a development plan for Kongelunden in a parallel assignment. It is presumed that continuous coordination between the two projects will take place following the conclusion of the contests.

The participants in the design contest must meet the following minimum requirements:

- The applicant must have had a pre-tax profit in two of the past three financial years.
- The applicant must have a solvency ratio of a minimum of 20% in the most recently concluded financial year.
- The applicant must have a minimum of one reference (case study) involving full-service consultancy services for a construction project with a capital sum of EUR 14m, which has been commenced or concluded within the past three calendar years.

If the application to participate is submitted by a consortium, all participants in the consortium must meet the minimum requirements regarding pre-tax profit and solvency ratio.

Applicants, including a participant in an association submitting an application, must not be subject to any of the grounds for exclusion set out in ss 135-137 of the Danish Public Procurement Act (udbudsloven) (see appendix 1 to the prequalification documents).

The participants in the design contest will be selected among the applicants meeting the above minimum requirements on the basis of an assessment of the applicants' qualifications in the areas of architecture and landscape architecture in the form of:

- a) experience developing and planning innovative, ground-breaking and robust architecture with international stature, including as a full-service consultant
- b) experience from construction projects of a high complexity within sports and culture
- c) experience integrating design
- d) experience developing architecture in a cultural historical environment, including links between historical and new buildings
- e) experience with architecture with a broad sustainability focus
- f) experience with focusing on the overall financial situation and financial management while operating within a fixed financial framework
- g) experience with partnering collaboration and project development (early invitation to tender for construction work)

New experience (references/case studies) are given a higher weight than older experience (references/case studies).

It will be given positive weight in the assessment if multiple of the above-mentioned disciplines (a-g) are included in the same reference/case study (project).

If more than 5-6 applicants have qualifications that are almost equal, it will in the selection of the final participants in the design contest be taken into account whether – and if so to what extent – the applicant's qualifications relate to construction work with the same characteristics as the new stadium of the Municipality of Aarhus

The winner of the design contest will be selected on the basis of one overall assessment of the following criteria:

- Architecture and functionality

Weight will be attributed to

- "New Stadium in Aarhus" appearing as a ground-breaking and beautiful building with international stature and quality.
- the holistic solution of the design proposal in relation to the surroundings to a high degree taking into account the cultural historical environment.
- "New Stadium in Aarhus" having insight into and an understanding of creating optimum fan and football experiences.
- the project being characterised by integrated design with realisable and value-creating sustainability solutions.
- Technology and the environment

Weight will be given to the proposal's quality and concepts in the areas of sustainability and technical solutions as well as the capability of execution taking into account the framework of the construction economics, and that the proposal is robust enough for scaling in relation to and in terms of future adjustments to the financial framework.

Weight will furthermore be given to optimizing of the operating costs of the proposal in terms of selection of materials and technical solutions.

- Consulting fee

Weight will be given to the fee rates offered, which are to be as low as possible within a realistic framework in respect of the performance specification.

According to Consolidation Act no. 593 of 2 June 2016 on the Complaints Board for Public Procurement, the following complaints deadlines apply in relation to inviting tenders:

Complaints about not obtaining prequalification must be received by the Complaints Board no later than 20 calendar days after the day on which the contracting authority has announced who has obtained prequalification.

Complaints regarding the tender procedure must be received by the Complaints Board for Public Procurement no later than 45 calendar days after the day on which the contracting authority has published an announcement in the Official Journal of the European Union stating that the contracting authority has entered into a contract. The deadline is calculated from the day after the day on which the announcement was published.
